NOTE: Every person competing in an open class must possess a current AQHA or AQHYA membership card issued by AQHA, or must fill out a membership application and pay for it at the show. Current amateur and youth cards must be shown. To be eligible for OQHA Oregon Bred awards, the horse must be registered with OQHA as Oregon Bred.

Any owner or exhibitor whose personal check (for show fees or stalls) fails to clear the bank, has 30 days to make the check good. If he or she fails to do so, points for that show will not count for year-end awards and could be subject to AQHA notification. There is a \$25.00 fee for each NSF check.
