**Information:**

To be eligible for OQHA year-end awards exhibitors and owners must be members. A horse must compete in a given class to a minimum of 14 judges for Open, Amateur and Youth at OQHA approved shows in the State of Oregon and earn a minimum of twelve (12) OQHA year-end points to be eligible for a year-end award. NEW for Youth: All judges and points from OQHA shows count for year-end awards. Rookie and Versatility Ranch Horse classes will be eligible for a trophy style year end award. Rookie & VRH classes will be eligible for a trophy style year end award if the above award rules are met (see OQHA year end award rules).

To be eligible for OQHA Oregon Bred awards, the horse must be registered with OQHA as Oregon Bred. Oregon Bred is a horse who was foaled in the State of Oregon as per AQHA papers.
