**Working Cowhorse Green** – Non Pro Rider –Dry work & box only. No fence work. Exhibitor can not have showed down the fence more than 5 times to be eligible for the class.

**Small Fry classes:** walk / trot 10 & under classes.

**\*\*Please note youth qualifying classes will be held concurrent with the youth 14-18 classes.** Please enter both your age division and the qualifying class if you are intending to qualify for the AQHYA youth world show. Must fill out the Declaration Form!!

**All Around Awards for the 4-day circuit:** Open, Novice Amateur, Amateur, Amateur Select, Novice Youth, Youth 13 & Under, Youth 14-18 **\*\*Must show in 3 AQHA categories to win All Around Award. All Around awards will be determined as per AQHA rule 417.**

This show is governed by the 2008 AQHA Handbook. Registration papers & membership cards will be checked. To be eligible for OQHA Oregon Bred awards, the horse must be registered with OQHA as Oregon Bred. **To be eligible for OQHA year-end awards exhibitors, handlers and owners must be members.**

Any owner or exhibitor whose personal check (for show fees or stalls) fails to clear the bank, has 30 days to make the check good. If he or she fails to do so, points for that show will not count for year-end awards and could be subject to AQHA notification. **There is a \$25.00 fee for each NSF check.**
